
The office of AGPR intends to auction the following used vehicles on "as is and where is basis" on February 24, 2022 at 11:00 AM at AGPR Office.

**Terms of Auction:-**

- l) The bidders must bring their original CNIC and provide complete address / telephone numbers and attested copy of CNIC on the day of Auction.
- m) Successful bidder must deposit earnest money i.e. 10% of the bid **in cash** on the spot and remaining amount must be deposited within **05 days** of auction. In cases of default, earnest money shall be forfeited.
- n) The payment of outstanding token tax / dues will be the responsibility of successful bidder.
- o) The bidder to participate in the bidding process shall deposit a refundable bid security of Rs.30,000/-(Rupees: Thirty Thousand Only) for the vehicles and Rs.5,000 /-(Rupees: Five Thousand only) for the motorcycles, in shape of demand draft in the name of **Branch Officer Admin-II, AGPR.**
- p) The transfer of ownership documents would be the responsibility of the successful bidder.
- q) Documents of the vehicle (s) will be delivered after complete payment only.
- r) Withholding tax on the bid amount shall be charged, as per prevailing rules
- s) Successful bidder shall check the chassis / engine number and documents etc, before taking over the vehicle; this office will not be responsible for any complaint later on.
- t) Possession of vehicles will be given to the successful bidder, after transfer of vehicle in his name from the ETO concerned.
- u) Other details will be announced at the time of auction.
- v) The Auction Committee / Competent Authority reserve the right to accept or reject any or all bids in accordance with rule 33 of the PPRA Rules, 2004.
